



## Terms and Conditions | Mint eCommerce Payments Plug-in Launch Offer

### 1. Eligibility

The offer is available to new and existing merchants transacting with Mint Payments. The best price guarantee is conditional upon the merchant providing evidence of the rate they are currently receiving for eCommerce payments in the form of a statement that has been issued by their existing provider.

### 2. Incentive

The eCommerce Launch Incentive will be the following:

- a. "Our Best Rate" guarantee

- b. Bonus Rewards Points  
2750 Mint Rewards points will be added to the merchant's Rewards balance if they are one of the first 50 merchants to sign up and begin transacting using the eCommerce Payments Plug-in.

The following conditions apply:

- This promotion only applies to blended pricing for your merchant service fee for both MasterCard and Visa payment methods.
- The promotion only applies to the same or equivalent credit card (MasterCard and Visa only) processing product which is part of Mint’s suite of products currently offered.
- The competing price rate you have must be a real dealing price rate given at the same time as our price offer and be supported with the last month’s complete merchant activity statement by the competitor bank acquirer.
